Programme: Media Studies / New Media and Digital Culture, Film- en televisiewetenschap (zie Nederlandse OER)

Article Text Requirements for admission to the programme 2.1 All students who start their Master's programme on the 1st of September 2016 or later, will encounter a selection procedure which must be completed successfully in order to enrol in the programme. 1. Consideration for admission to the degree programme Mediastudies requires a Dutch or foreign diploma that demonstrates knowledge, understanding and skills at the level of a university Bachelor's degree and that shows its holder has the following specific knowledge, understanding, and skills: a) basic knowledge of theories and debates concerning Media and Cultural Studies; b) understanding of the functioning of media in contemporary culture and everyday practices; c) understanding of the role of media within cultural industries; d) general academic skills, and in particular those needed to independently conduct (media-cultural) research. 2. The following conditions for consideration for admission apply to the various programmes. Programma Film- en televisiewetenschap See Dutch OER. Programme New Media & Digital Culture - knowledge of and insight in New Media and Digital Culture theories and debates; - knowledge of qualitative and/or quantitative research methods particular to the Humanities and/or Social Sciences, as well as working knowledge of the main concepts used in Media and Cultural Studies; - social and intercultural communication skills necessary for effective and professional functioning in collaborations with fellow students and internship colleagues. 3. Students will be selected on the basis of an assessment of the following core competencies: a) motivation and talent (also on the basis of GPA and student progress monitoring); b) level of required knowledge and the mastery of methods and techniques used in the subject area; c) general high level of professional and intellectual ability; d) command of the language(s) used in the programme. This information is used to consider whether the student concerned is in a position to complete successfully the Master's programme within the nominal time period. 4. There is a fixed quota for admission to the programme New Media and Digital Culture. The maximum number of students to be admitted to this programme is 40. The admissions committee referred to in Article 2.5 will rank the applications received using the criteria set out in the second paragraph and will accept applications for admission by their ranking.

2.3 Admission procedure

- 1. Admission decisions are made by the Admission Committee 60 and 90 EC Programmes of Utrecht Graduate School of Humanities, Chamber Master Degree Programmes (MA and RMA).
- 2. In order to determine eligibility for admission to the programme, the Admission Committee will carefully consider and evaluate the knowledge, insights and skills of the applicant. The committee may request experts within or outside the university to assess the applicant's knowledge, insights and skills in particular areas, in addition to a review of written documents of qualifications gained.
- 3. In order to determine eligibility for admission to a study programme within the programme, the Admission Committee will check if the applicant fulfils or will fulfil the requirements referred to in art. 2.1 before the established deadline date. In its evaluation the committee will use the core competencies set out in art. 2.1 third paragraph when assessing as well as the applicant's command of the language in which the programme is given. On the basis of this, the admissions committee will assess whether the candidate is capable of demonstrating sufficient commitment to be able to achieve the Master's degree qualification within the prescribed period.
- 4. Admission assessments for New Media and Digital Culture take place twice a year.
- 5. A request to be admitted to the study programme New Media and Digital Culture, must be submitted with the Admission Committee before <u>1 April.</u> For foreign students who wish to apply for scholarships or who need an early notification of admission, a request to be admitted to the study programme must be submitted to the Admission Committee before <u>1 December</u>.
- 6. The Admission Committee will make an admission decision within 6 weeks after the application deadline (1 December or 1 April), but only on having received the complete file. Admission will be granted on the condition that by the starting date of the study programme the applicant will have satisfied the knowledge and skills requirements referred to in art. 2.1, as evidenced by certificates of qualifications.
- 7. The applicant will receive written notification that he/she has been admitted or not to the degree programme and a particular study programme. The possibility to appeal to the Examinations Appeals Board is pointed out in this notification.
- 8. The applicant will accept a notification of admission. A notification of admission that has not been accepted within two weeks will expire.

3.1 Aim of the programme

1. The programme aims to:

- provide specialised knowledge, skills and insight in the field of Media Studies;
- prepare the student for a career as a specialist in the field of Media Studies:
- prepare the student for conducting research in the field of Media Studies.

- A) has in-depth knowledge of and insight into the field of New Media and Digital Culture in the Humanities;
- B) has specialized knowledge of at least one sub-area of study within the field of New Media and Digital Culture as presented in the core and/or elective courses;
- C) has the skills to independently identify, analyse and criticize methodological and theoretical concerns in the field of New Media and Digital Culture in an academic fashion, and is able to apply these concerns to examples or case studies in written as well as oral forms of academic expression;
- D) has the skill to independently conduct research on New Media and Digital Culture and to report on it in a manner that meets the academic standards of

Algemene opmerkingen
