# **Program Information**

# **Nomination Procedure**

Nomination deadline: April 15

# **Application & Requirements**

Nominated exchange students should be:

- officially registered students at one of our partner universities
- in good academic standing
- officially nominated by the home university
- applicants must have completed at least one year of a full-time undergraduate law programme or at a graduate law school by the time the programme begins

Nominated exchange students will receive an email from the EBS International Programmes Office including details of the online application procedure and login data within 2-3 working days.

Students upload the following supporting documents into the application system:

• For non-native speakers of English TOEFL, IELTS, TOEIC or ESOL:

TOEFL	90 iBT
IELTS	6.5
TOEIC	721
ESOL	CAE grade A, B, C

- current CV or resume
- a copy of all university transcripts (in English)
- proof of sufficient health insurance valid in Germany/Europe for the entire stay at EBS
- copy of ID document: for EU-students: national ID card for non-EU-students: passport
