2.1	<p><b>Requirements for admission to the programmes</b></p> <ol style="list-style-type: none"> <li>1. Consideration for admission to the degree programme <b>International Relations</b> requires a Dutch or foreign diploma that demonstrates knowledge, understanding and skills at the level of a university Bachelor’s degree and that shows its holder has the following specific knowledge, understanding, and skills:           <ol style="list-style-type: none"> <li>a) demonstrated understanding of the current state of empirical, historical, and theoretical knowledge of international relations, and more specifically of armed conflicts and their relations to human rights issues at both inter-state and intra-state levels;</li> <li>b) competence in working with qualitative research methods, demonstrated either through course work or through having conducted historical or contemporary evidence-based research for a BA thesis relevant to the field of international relations in general, and/or conflict studies and human rights in particular.</li> <li>c) demonstrated proof of the following scholarly and academic skills:               <ol style="list-style-type: none"> <li>i. the skill to formulate clearly articulated, focused, and researchable (research) questions;</li> <li>ii. the ability to present a line of logical argumentation, either in writing or verbally;</li> <li>iii. the ability to write down one’s organized thoughts in a clear and structured way, fluently in the English language;</li> <li>iv. the ability to support arguments with empirical evidence, such as from historical documents, or from social-scientific data, or any triangulated combinations;</li> <li>v. where relevant, the ability to make sense of one’s arguments and empirical evidence through theoretical ideas and concepts, in either a case-specific or comparative manner.</li> </ol> </li> </ol> </li> <li>2. The following conditions for consideration for admission apply to the various programmes.           <p><i>Programme Conflict Studies and Human Rights:</i></p> <p>Consideration for admission into the programmes Conflict Studies and Human Rights requires:</p> <ul style="list-style-type: none"> <li>• subject knowledge of and insight in the fields of Conflict Studies and Human Rights to be demonstrated by at least 30 EC in relevant coursework;</li> <li>• knowledge of research methods relevant to the field of Conflict Studies;</li> <li>• the ability to present a feasible and relevant preliminary research idea for your Master’s thesis;</li> <li>• skills pertaining to critical, analytical, and structured essay-writing skills in English;</li> <li>• excellent scholarly abilities demonstrated by an academic track record of high grades;</li> <li>• practical and/or professional experience in conflict zones, or in the field of conflict resolution and peace building, or demonstrable interest in this field of study.</li> </ul> </li> </ol>

	<p><i>Programme International Relations in Historical Perspective:</i></p> <p>Consideration for admission to the programme International Relations in Historical Perspective requires:</p> <ul style="list-style-type: none"> <li>• knowledge of the history of international relations during the 19<sup>th</sup>, 20<sup>th</sup> and 21<sup>st</sup> century and acquaintance with complex theories in the field of international relations;</li> <li>• knowledge of research methods in the field of history, and contemporary history;</li> <li>• academic and analytic skills: the ability to design, carry out, and report both in writing and orally on historical research in the field on international relations.</li> </ul> <p>3. Students will be selected on the basis of an assessment of the following core competencies:</p> <ol style="list-style-type: none"> <li>a) motivation and talent (also on the basis of GPA and student progress monitoring);</li> <li>b) level of required knowledge and the mastery of methods and techniques used in the subject area;</li> <li>c) general high level of professional and intellectual ability;</li> <li>d) a good command of English.</li> </ol> <p>4. There is a fixed quota for admission to the programmes. The maximum number of students to be admitted to the programme Conflict Studies and Human Rights is 60. The maximum number of students to be admitted to the programme International Relations in Historical Perspective is 60. The admissions committee referred to in Article 2.3 will rank the applications received using the criteria set out in the second paragraph and will accept applications for admission by their ranking.</p>
<p><b>3.1</b></p>	<p><b>Aim of the programmes</b></p> <ol style="list-style-type: none"> <li>1. The learning objective for the student is to gain specialised knowledge, skills, and understanding of the field of International Relations; specifically, 'International Relations in Historical Perspective' and 'Conflict Studies and Human Rights.'</li> <li>2. The aim, therefore, is to equip students with the skills, knowledge and understanding needed for careers as analyst and policy advisors, particularly in governmental and non-governmental organisations that deal with international issues.</li> <li>3. The programmes also prepare students to conduct further research in the field of International Relations, specifically 'International Relations in Historical Perspective' and 'Conflict Studies and Human Rights'.</li> </ol> <p><i>International Relations in Historical Perspective</i></p> <p><u>The graduate:</u></p> <ol style="list-style-type: none"> <li>I. Will have gained in-depth knowledge of the history and theory of international relations with specific emphasis on how the modern world and its state system developed throughout history, while gaining insight in specialized topics related to the subject areas Global and Imperial Relations, Europe and the World, and Conflict and Security;</li> <li>II. Will have gained skills in the field of International Relations in Historical Perspective and will be able to conduct independent research by identifying, formulating and analysing a research problem, synthesizing the generated knowledge based on original source materials and relevant scholarly literature, and reflecting critically on the historiography in order to contribute new knowledge to the discipline;</li> <li>III. Will have gained skills to design, conduct and present independent research in the field of International Relations in Historical perspective in a manner that is consistent with the norms and standards of the</li> </ol>

Will be able to present knowledge and insights in a coherent and convincing manner to an audience of specialists and non-specialists alike by written, visual and oral communication means and to actively participate in group work and discussions in an international and diverse group;</p> <p>V. Will be able to apply the skills and knowledge at an academic level and/or in a professional setting within the labor market or to pursue another academic study at Research Master's or PhD level.</p> <p><i>Conflict Studies and Human Rights</i></p> <p><u>The graduate:</u></p> <p>I. Will have gained in-depth knowledge of the field of Conflict Studies and Human Rights, including (a) a capacity to critically evaluate current theoretical approaches to analyse violent and protracted conflict, and the different types of interventions and policies that aim to manage or resolve these conflicts; (b) knowledge of human rights and their relevance and interaction with the political and practical context of societies facing these conflicts;</p> <p>II. Will have gained a critical awareness of current problems and new insights in the field of Conflict Studies and Human Rights;</p> <p>III. Will have gained skills to analyse situations of violent and protracted conflict, can use and critically reflect on different analytical techniques and methodologies, and can make sound judgements of the quality of the analysis made in academic texts, newspapers and reports;</p> <p>IV. Has gained specialised and competent knowledge of a subject area within the field of Conflict Studies and Human Rights through self-directed learning and specialisation;</p> <p>V. Will be able to present knowledge and insights in a coherent and convincing manner to an audience of specialists and non-specialists alike by written, visual and oral communication means and to actively participate in group work and discussions in an international and diverse group;</p> <p>VI. Will have gained skills to design, conduct and present independent research in the field of Conflict Studies and Human Rights in a manner that is consistent with the established norms and standards of the academic field;</p> <p>VII. Will be able to apply the skills and knowledge at an academic level and/or in a professional setting within the labor market or to pursue another academic study at Research Master's or PhD level, and can act autonomously in planning and implementing tasks at a professional or equivalent level.</p>

### **General remark**

The new compulsory courses are equivalent to the old courses (see below), unless stated otherwise. If a student has completed the old course, the new equivalent course can't be taken as well.

Students who still need to complete one or more electives, should choose from the courses offered in 2022-2023. They should make sure to choose a course that does not have a major overlap with already completed courses. Courses with too much overlap are indicated in the tables below. If two courses are labelled equivalent, only one of them can count toward the student's study programme.

It is possible to make the transition from the exam programme of an earlier cohort to the programme of the current academic year (2022-2023). If the student chooses to do so, they must comply to all regulations of the exam programme of the current academic year and must request approval from the Board of Examiners.
